The 2020 PMHS Female Athlete of the Year: During the Fall Season, she was team captain and leader of the varsity team. Her commitment and leadership to the team did not go unnoticed by her coach or teammates. The younger players looked up to her and saw her as a role model. She led the team with 7 goals and 7 assists. She was awarded the Coach's Award and earned All-Conference honors for the Granite State Conference South. She was also named to the Division IV All-State Team. During the Winter Season She was one of the most fierce and energetic players on the floor. She did a lot of things that did not appear in the score book but were essential to her team's success. She was always the first on the floor for a loose ball, and never afraid to dive into a pile if it helped her team. She practiced and played hard and it showed in her improvement over the course of the season, especially on defense, where she was often tasked with guarding the opposing team's top players. **The 2020 PMHS Female Athlete of the Year goes to Kianna Vincelette.**

The 2020 PMHS Male Athlete of the Year: During the Fall Season, this co-captain started all 17 games as our center midfielder. He led the team with 13 goals in 17 games. He is a tireless worker on both sides of the ball. He's a natural leader by example and has learned to assert himself vocally. He was the recipient of the Golden Boot Award and the Mark Watkins MVP Award. He was also elected to the Granite State All Conference Team. During the Winter Season, he was the team's top defender and was always tasked with guarding the other team's top scorer. Collectively, this season, he limited 9 of the opposing team's top scorers to single digits. His efforts were not only noticed by his teammates, he was named Defensive Player of the Year for PMHS, as well as the NHBCO Defensive Player of the Year, voted on by all division coaches. He helped guide the Panthers to a record of 14-4 and their second Final Four appearance in three seasons. He excels in the classroom and was named to the NHBCO All-Academic Team. **The 2020 PMHS Male Athlete of the Year goes to (#1) Jesse MacGlashing.**

Proposed Reopening Plan for Pittsfield Schools

The plan outlines a proposal for all learning to be online, with the support of students coming into school in a hybrid model. This means students will have the option to be on-site in small cohorts on a part-time basis, or to work fully remotely. The first day of school will be September 3.



Cook's Corner

Baked Cod with Pesto

Here's a new, easy spin on classic baked fish. You can substitute the cod for whatever fresh fillets you can find, such as haddock, tilapia, or monkfish. In addition to being tasty and light, this dish also presents well. Don't forget – we eat with our eyes first! Bon appetit!

- 1 lb cherry tomatoes (yellow & red)
- Reserve a few pieces of tomatoes for garnish
- 2 cod fillets, about 1 to 1½ lbs.
- 8 Tbsp prepared pesto sauce
- 2 shallots, very thinly sliced
- Olive oil
- Salt & pepper
- Fresh basil leaves for serving

Heat oven to 450. Slice tomatoes in half and place in an oven proof baking pan or dutch oven – place the tomatoes, cut sides up, in two rows of two. Top the two 'batches' of tomatoes with the shallots.

Place the fish fillets on top of the tomatoes / shallots. Using about ¾ of the pesto, spread on top of the fish. Season with salt & pepper and lightly drizzle with just a little olive oil.

Cover the dish with foil, shiny side down. Roast in the oven for about 20 minutes or until the fish is cooked through. Add more pesto if needed and top each fillet with two sliced tomatoes and a small basil leaf.

Carefully remove the fish, with the tomato slices underneath, to the dinner plates. Serve with sliced lemon. Cooked linguine dressed simply with olive oil and fresh grated Parmesan would be lovely alongside this fish, with maybe garlic bread and a salad.

"No, I insist. Ladies first." The man waved her in.


Separately, they entered into the offices of Fannigan, Brower and Issac, Esquires.
