





On March 16th, many 4-H clubs met at Merrimack Valley High School for Merrimack County 4-H Presents, an annual event to hone in on communication skills. Seventeen Victory Workers Members participated in a variety of activities such as Public Speaking, Action Exhibits, Photography, Posters, FLX Video Contest, and Demonstrations. In addition, there were four Victory Workers Cloverbuds (kids ages five to seven) who participated in pet rock showmanship, and/or show and tell of their choice. ## Select Board Review--April 9, 2024

After a public hearing (required for 'items' over \$5000 value), we accepted a \$5,580 DataPilot device for the police dept. from Operation Underground Railroad that will assist in investigations such as child porn. In addition, we accepted a monetary grant of \$5,000 (\$10k public hearing threshold for cash donations) for cruiser antennas and computer stands.

The Pittsfield Clothes Closet made three more donations for town related purposes totaling \$2,200. Once again, we thank them and their donors/patrons for all the good they do.


Fred Hast was appointed public voting member of BCEP. Dan Schroth will continue on the BCEP budget committee.

A parade permit was approved for Old Home Day (back to the original route).

A long discussion was held with the head of Public Works, Noel Gourley. We continue to be battered by heavy rains and most recently 12-14" of heavy snow. So that taxpayers are informed, it takes at least a year to obtain a truck after it has been voted on by town meeting, due to manufacturing lag times, therefore, just because a truck may be approved by voters it doesn't mean we'll have it in less than 12-14 months. One item that was approved and we were able to take immediate delivery of was a new chipper which was put to work the day it arrived and has seen consistent use since, grinding up tree limbs. Also, Noel reminded us that he has had to plow some roads with the grader, which is not his first choice. However, if we see the grader out it means one of two things; either a truck is out of service or there's over a foot of snow and he needs it to get through drifts. Road ditching will start right away, to then be followed up with road grading, after ditching has been completed. We discussed several driveways that have failed/substandard culverts that are causing the dirt road to be damaged when they aren't functioning adequately. It is important that property owners are not confused by assumptions and misinformation regarding driveway culverts and their liability for them. State LAW, not town, dictates the entire responsibility for driveway culverts and any damage to public roads squarely on the property owner, NOT the town. The RSA (Title XX, Transportation, Excavation and Driveways, Chap 236, Section 236:13 VI) is now posted on the Town website in its entirety, but in sum, if your culvert is damaged, plugged or otherwise faulty or ineffective, you the property owner are responsible and the Town will hold you to it. Public funds will not be used to correct private property issues.

\$300,000 in collected ambulance transportation revenue was transferred to the town's general fund.

Other housekeeping items were cleaned up as well as appointing Jackson Marston as official clock-winder, with backup from Peter Marston. We had many interested applicants and we thank everyone for stepping up to offer their help. Carl Anderson

## **Balsamic Chicken with Whole Wheat Pasta & Zucchini Noodles**

Welcome Spring! It seems we're finally moving in the right direction weather-wise; and I'm sure we're all looking for ideas for healthy and flavorful meals. This dish is lovely and if you haven't tried "zoodles" yet, you really should! You can find a variety of vegetable noodles in the produce aisle. They are delicious and great way to add more vege (and less carb) to your diet. In this recipe we combine a small amount of whole wheat pasta (linguine or spaghetti is fine) with zucchini noodles. Enjoy!

## **Balsamic Chicken with Whole Wheat Pasta & Zucchini Noodles**

Cooking spray

½ cup balsamic vinegar

1 (28 oz) can diced tomatoes, drained

½ tsp Italian seasoning, or a combo of dried oregano, basil & garlic powder

1 & ½ lb boneless chicken breast cutlets (thin sliced)

¼ tsp salt

1/8 tsp black pepper

1 TBSP olive oil

4 oz dried whole wheat spaghetti

4 cups fresh zucchini noodles (12 oz), you'll find in the produce aisle

4 oz fresh mozzarella cheese, sliced

1 cup fresh basil leaves, thinly sliced

Heat oven to 425. Coat a 13 x 9 inch baking dish with cooking spray. In a small saucepan bring vinegar to boiling. Reduce heat to a lively simmer, simmer for 8 to 10 minutes or until reduced by half.

Meanwhile, in the prepared baking dish stir together tomatoes and Italian seasoning. Bake the sauce for 10 minutes.

Season the chicken cutlets with salt & pepper and a little garlic powder. Heat 1 TBSP olive oil in a large skillet and pan fry the chicken until golden brown on both sides, about 3 to 4 minutes per side. Pan fry the chicken in batches if necessary, remove to a plate and keep warm,

Remove sauce from oven. Nestle the chicken into the sauce and then top the chicken with the mozzarella slices. Bake for 8 to 10 minutes or until cheese is melted.

Meanwhile, cook spaghetti according to package directions; drain and return to pot. Add zucchini noodles to the cooked pasta, stir well to combine (using tongs). Cover and keep warm.

Serve the chicken over the spaghetti / zoodle mixture. Drizzle with the vinegar reduction and top each serving with fresh chopped basil.

Put out some fresh grated Parmesan cheese and toasty hard rolls, maybe a nice salad and you're good to go.

We are officially in the crossover period, during which all passed bills from the House and Senate will switch bodies for approval. This review covers two House Sessions: March 28, which addresses floor bills, and April 11, which covers all bills requiring Finance Committee approval.

**March 28 bills of interest:** An attempt to reconsider **HB1283**, known as the right-to-die bill and passed on April 12 by a slim margin (179-176), failed (147-210). This bill establishes a procedure for the terminally ill to receive medical assistance in dying.

**HB1539** passed on a bipartisan vote (283-80), allowing additional annulments, re-sentencing, and discontinuance for certain cannabis offenses. **HB1014**, which requires that election and voting laws be part of the high school curriculum, passed by on a voice vote. **Both HB1084**, which required that the commissioner of education be a certified teacher, and **HB1452**, which expanded the certifications for School Superintendents, were tabled. **HB1093** prohibiting mandatory mask policies in schools passed (187-184). The majority felt that the masks caused more problems than they cured! **HB1616**, relative to parental consent and control, expanded parent enrollment for student's participation in Medicaid in school programs, passed (190-187). If this becomes law, the parent will know all the medical care their child had through school.

**HB 1091**, passed by a voice vote, made significant changes to the state laws regulating the financing of political campaigns. If you are considering running for office, make sure you re-familiarize yourself with RSA 664:2 if this becomes law. **HB1596** is the first state bill addressing AI. It requires the disclosure of all deceptive media and fraudulent deep fake usage in political advertising and was passed by a voice vote. The first such use was in NH during the presidential primary when a fake phone message from President Biden told voters not to vote in the primary. **HB1280** codified best practices in doctor-patient relationships with informed consent and patients' rights to improve health care services passed (189-181). **HB1568**, which allowed Medicaid reimbursement for non-transport emergency services, passed (237-126). If this becomes law, EMT services can be reimbursed when the EMTs are able to handle the situation on-site.

**HB1607** expanded safe haven protections to mothers giving up their babies for adoption by placing the child in a safe haven box and passed (372-1). Both **HB1291** (increasing accessory dwelling units to 2) and **HB1399** (allowing the expansion of a single-family residence to a duplex with a residential zone in an urban area) passed (220-143 and 220-140). Both of these bills interfere with local land use control and I did present the problems to the Board of Selectmen. **HB1711**, which allowed the confiscation of firearms following certain mental health-related court proceedings and reported mental data for firearm background check purposes, passed (204-149). Twenty-five Republicans voted for this bill. Cyril and I did not because it the bill would be easily abused because the mental health definition was too broad!

**April 11 bills of interest:** The House had already passed all bills moved on by the Finance Committee, so many passed by voice vote. The main problem is that the legislature cannot raise additional funds in the second year, so even if a bill is passed, there may not be money to enact into law.

**HB1199** established an office to identify and develop programs to support youth experiencing homelessness, failed by a slim margin (192-191). The money for the addition of another position was not available! **HB1212** increased the free school meals to household incomes threshold to 350% failed (192-191). The supporters tried to convince the legislature that over 50% of the children in NH go hungry! **HB1288**, which established due process rights for students, student organizations, and faculty members facing disciplinary actions by state institutions of higher learning, passed (196-184). Testimony convinced the majority that the process in place needed fixing! **HB1363**, which allowed members of the general court to participate in the Department of Health and Human Services employee assistance program, was tabled (195-186). Some legislators wanted benefits!

**HB1577**, which enabled the digital images of ballots produced by the newly approved voting machines to be available for public viewing, was tabled (193-188). I was a co-sponsor of this bill. Having this information would easily provide data that could be used to help both sides prove they are right!

**HB1633** established procedures for the legalization, regulation, and taxation of cannabis passed (239-136). Last year, the Senate, with a clear Republican majority, voted this down. Considering all the ills that are associated with marijuana, we look to the Senate to squash it.

**HB1649**, which restricted the use of polyfluoroalkyl substances (PFAS), passed (233-140). This bill's ramifications are very broad and cover chemicals that are used in many everyday products. For example, even Teflon, which is used in medical equipment, would fall within this definition.
